ASPECT4 Finance Y23Q1

ASPECT4 Finance Y23Q1 includes new functions for immediate deployment along with new conditions that will be implemented or expanded in future releases.

Among other things, the option of correcting the payment reference and/or payment information for the individual payment has been added to automatic payment receipt. It is also possible to write a specific transaction text on the individual line.


When a SAF-T report is created in a Norwegian company, the transactions are now split into several files so that large amounts of data can be handled.


In addition, the release contains a number of quality assurances and the elimination of some flaws.

The new functions, the implementation of quality assurance and elimination of flaws are described at the task level in the following.
